Use De-Identified Data to Understand Disease Progression and Improve Intervention

## **Examine COVID-19 Patterns**

The American healthcare system is in the midst of an unprecedented crisis. The application of insight drawn from de-identified national healthcare data offers information that allows researchers to trace the patterns and trends crucial to solving this crisis.

To support our customers as well as the overall healthcare community, Change Healthcare has developed the **Market Insights: COVID-19 Analytic Data Sets** to provide consolidated, de-identified<sup>1</sup>, and timely analytic data relevant to the pandemic.

#### **Enable Longitudinal Analysis**

The de-identified data, derived across institutional, professional and ambulatory settings, depicts both explicit and inferred SARS-CoV-2/COVID-19 diagnoses, tests, and care, comprising three analytic data sets:

- The first includes claims with explicit COVID-19 test and diagnosis codes, depicting SARS-CoV-2/ COVID-19.
- The second includes claims with billing codes identified in the CDC interim billing guidelines issued in February 2020.
- The third contains claims with a selection of respiratory management diagnosis codes.

These analytic datasets enable robust longitudinal analysis to help data scientists understand disease progression, optimize intervention, and ultimately, remediate SARS-CoV-2/COVID-19.

#### **Track Tests and Diagnoses**

The data sets provide a robust and timely depiction of the state of SARS-CoV-2/COVID-19 in America. Each dataset includes de-identified claims containing selected tests, diagnoses, or procedures of up to four years' history. The datasets are updated daily as new information is processed.

## Analytic Data Set 1: COVID-19 Explicit Test and Diagnosis Codes

The first analytic data set includes claims with an explicit SARS-CoV-2/COVID-19 test or diagnosis code.

# Analytic Data Set 2: COVID-19 CDC Interim Billing Guidelines

The second analytic data set includes claims that contain billing codes specified in the interim billing guidelines issued by CDC in February 2020<sup>2</sup>, indicating SARS-CoV-2/COVID-19 activity.

#### Analytic Data Set 3: SARS-CoV-2/COVID-19 Inference Through Respiratory Management

The third analytic data set includes HCPCS claims related to respiratory management which were used to code early cases of the virus.
