RE: An Open Letter of Acknowledgement and Apology by Dr. Lawrence A. Farwell to Brainwave Science and its Directors, Management, Business Associates and Clients.

To Whom it May Concern,

My name is Dr. Lawrence A. Farwell. I am a research scientist and inventor. I previously maintained a business relationship with Brainwave Science, Inc. in Southborough, Massachusetts. I am writing this open letter of acknowledgement and apology to address certain wrongful actions and false statements directed toward Brainwave by myself which have harmed Brainwave and its Management, Directors, Business Associates and Clients.

In or about 2012, I began a working relationship with Krishna Ika and Brainwave Science. At or about that time, I entered into a series of IP Assignment Agreements wherein I agreed to assign Brainwave all rights, title and interest to my "Brain Fingerprinting" application. This assignment also included several patents, including patents I had obtained which related to "Brain Fingerprinting. At the time I executed the IP Assignment Agreements, I unequivocally assured Mr. Ika and Brainwave that I had authority to execute the agreements and convey the subject intellectual property. I was granted an equity interest in the company and thereafter served as the Chief Scientific Officer for Brainwave through in or about June 2016. While serving as a Chief Scientific Officer, I received ongoing salary payments to assist Brainwave in further developing the "Brain Fingerprinting" application and other related intellectual property.

In October 2013, I filed documents with the United States Patent and Trademark Office ("USPTO") disputing the validity of the IP Assignment Agreements and patent assignments I had previously executed. I filed the documents on behalf of Brainwave despite my having absolutely no authority to do so. I did not tell Mr. Ika or Brainwave's management about this subsequent filing with the USPTO. During the three years following my filing with the USPTO, I continued collecting salary payments from Brainwave for development of the assigned intellectual property.

Also, during that three-year period, I sold a portion my equity in the company. I did not tell the

purchaser of my shares about the purported correction I had filed with the USPTO.

In or about June of 2016, I drafted correspondence to Brainwave's management and

business associates. The correspondence which I drafted was forwarded to Brainwave from

another entity, previously unknown to Brainwave. I drafted the correspondence under the name

of another person. The signatory of the correspondence was a friend of mine who served, unpaid,

as "President" of the other entity. The correspondence accused Brainwave and Mr. Ika of

committing fraud, alleged they did not own the intellectual property subject to the IP Assignment

Agreements and demanded damages.

Following my departure from the Brainwave, I continued to use and market the code and

other intellectual property that I had conveyed to Brainwave by way of the IP Assignment

Agreements. In 2017, I initiated contact with Brainwave's Chief Technology Officer, Dr. Thierry

Maison, for the purpose of obtaining code for use in the program I was continuing to market. Dr.

Maison, who was tasked with developing Brainwave's code, was subject to non-disclosure and

confidentiality agreements with Brainwave. Despite this, through my contacts with Dr. Maison, I

obtained copies of code developed by Dr. Maison and Brainwave's team for Brainwave. I used

this code within my own program which I continued to market to international clients and research

institutions.

Also following my departure from Brainwave, I made a number of public statements

disparaging Mr. Ika and Brainwave Science. Within these statements, made on my personal

website and elsewhere, I falsely accused Mr. Ika and Brainwave of committing fraud and

marketing a "counterfeit" technology.

I deeply regret my dishonest actions and false statements directed toward Brainwaye and

Mr. Ika. A number of my statements were patently false. Many others were made without

foundation and in reckless disregard of the truth. My conduct and actions directed toward

Brainwave and its management were deceitful, unbecoming of a member of the scientific

community and frankly inexcusable.

I recognize and hereby acknowledge, and take full responsibility for, the wrongfulness of my statements and actions directed toward Brainwave and Mr. Ika. I sincerely regret, and apologize for, the harm and embarrassment that my false statements and dishonest conduct have caused Brainwave, Mr. Ika and Brainwave's customers and business associates. I hope to make amends and to move forward in a spirit of honesty, integrity, and respect for others.
